

NCTU License Plate Application Instructions

1. Fill out the following NC DMV application form.

All information on the application form (except the Office Phone Number) is required and should be on your current vehicle registration.

Please print LEGIBLY.

Note: "Date of Certification" is the date the application was signed, i.e. today.

2. Make out a check or money order in the appropriate amount, \$20 or \$50, to (Sorry, we cannot accept cash):
